# Annex -Risk and Consequences of being treated as Professional Investor

# 1. Treatment as a Professional Investor

We refer to your request for opening or maintained a Professional Investor account with Master Trademore Securities Limited ("the MTSL"). Based on the information you or your company have provided to us which shows you or your company, and in view of your representation and warranty that you or your company is/are a Professional Investor, we will be exempt from complying with certain compliance requirements listed below under the Code of Conduct for Persons Licensed by or Registered with the Securities and Futures Commission ("the Code") provided always that you or your company agree to be treated as the Professional Investor and agree to inform us promptly if any information you or your company have provided to us for the Professional Investor assessment ceases to be accurate or changes in any other way:

## (1) Exempt Provisions for Corporate Professional Investors

## (a) Information about Clients

- (i) The MTSL will not be required to establish your company financial situation, investment experience or investment objectives except the MTSL are providing advice on corporate work;
- (ii) The MTSL will not be required to ensure the suitability of a recommendation or solicitation; and
- (iii) The MTSL will not be required to assess your company knowledge of derivatives and characterize your company based on your company knowledge of derivatives.

## (b) Client Agreement

(i) The MTSL will not be required to enter into a written client agreement and the provision of relevant risk disclosure statements.

# (c) Information for Clients

(i) The MTSL will not be required to disclose transactions related information to your company.

# (d) Discretionary Accounts

- (i) The MTSL will not be required to obtain from your company's authority in writing prior to effecting transactions for your company in the discretionary account without your company's specific authority;
- (ii) The MTSL will not be required to explain the authority described in discretionary account and confirm it on an annual basis;
- (iii) The MTSL will not be required to disclose benefits receivable for effecting transactions for your company under a discretionary account.

# (2) Exempt Provisions for All Professional Investors

## (a) Information for clients

- (i) The MTSL will not be required to inform you or your company about the licensed person and the identity and status of our employees and others acting on its behalf;
- (ii) The MTSL will not be required be to confirm promptly with you or your company the essential features of a transaction after effecting a transaction; and
- (iii) the MTSL will not be required to provide you or your company with documentation on the Nasdaq-Amex Pilot Program.

# 2. Right to withdraw from being treated as a Professional Investor

Under the Code, you or your company has the right to withdraw from being treated as a Professional Investor at any time in respect of all investment products or markets or any part thereof by giving written notice to the MTSL. You or your company shall inform the MTSL in writing immediately if you or your company no longer falls into the categories of persons described in paragraphs (a) to (i) of the definition of "professional investor" in Part 1 of Schedule 1 of the SFO or under the Securities and Futures (Professional Investor) Rules.
